

GSEF2020 OBJECTIVES

-  Exchange experiences of sustainable economic development based on the Social and Solidarity Economy, and concretely collective and community entrepreneurship.
-  Identify public policy projects or initiatives in line with the achievement of the Sustainable Development Goals through Social and Solidarity Economy developing both in rural and urban areas, with special emphasis on indigenous peoples and communities.
-  Identify the most representative challenges of the Social and Solidarity Economy and discuss on how to find local solutions and innovative, effective ways for its adequate execution.
-  Reinforce the establishment and strengthening of the Social and Solidarity Economy through networking of cooperatives and other Social and Solidarity Economy actors.
-  Underline the relevance of the Social and Solidarity Economy in the creation of decent work and the strengthening of sustainable and fair production and consumption chains, and towards the ecological transition.
-  Ensure the active participation of young people, women, indigenous peoples & First Nations in all aspects of the forum.

II. CENTRAL THEME

Social and Solidarity Economy for Sustainable, Inclusive Development and Well-being

This central theme incorporates the fundamental principles of GSEF as an international association of local governments and civil society actors committed to the development of the Social and Solidarity Economy (SSE). It is articulated around four thematic pillars directly related to the debates that are currently taking place in Latin America and all around the world by recognizing Social and Solidarity Economy in its diverse expressions, as a real, viable and sustainable option to advance social and economic development to achieve an ecological transition in a different way.



In a global context often marked by growing inequalities, local and national governments around the world – in both developed and developing countries – are increasingly turning to the Social and Solidarity Economy model for the role it can play in the generation and distribution of collective wealth. SSE is a model that integrates wealth distribution from the very inception of the economic activities. As a result, it allocates an essential part of the generated wealth in favor of sustainable and inclusive development goals.

The Social and Solidarity Economy has demonstrated in times of economic crisis and significant job losses, greater resilience and lower vulnerability to these problems due to its more transparent, sustainable and responsible socio-business policies.

GSEF2020 will bring the perspectives of Mexico and Latin America to the center of the international debate while sharing diverse views at global level on how Social and Solidarity Economy can contribute to the transformation of societies in a more inclusive and sustainable way as a real alternative for the economic and social development of territories and to the well-being of all citizens.

III. THEMATIC PILLARS & SUB-THEMES

Economic Development & Wellbeing

In a context where inequalities and the wealth gap that are continuously on the rise on a global scale, societies offering fair chances and equal opportunities for all is far from being a reality. Too often, the pursuit of profit maximization is still the most important objective in all economies, generating an increasingly uneven wealth distribution worldwide. According to a 2019 Oxfam report, the fortunes of the world's billionaires increased by 12% while the income of 3,8 billion of the poorest decreased by 11%. Against this background, citizens all around the world are demanding a deep transformation of our economies, cities and territories. To respond to these aspirations, governments increasingly turn to the new economic development paradigm embodied by the Social and Solidarity Economy (SSE). SSE is not only an alternative way of delivering economic, social and environmental value, but also a smart way of unlocking resources through - among others - social financing mechanisms. Under this thematic pillar, discussions will examine ways to tap into SSE's potential to contribute to economic transformation towards the achievement of the spirit of the Agenda 2030, "to leave no one behind".

Environmental Resiliency

The world is facing ecological crises including floods, global warming and air pollution, revealing the failures of the "business-as-usual" attitude by governments, producers and even consumers. These practices neglect the critical importance of sustainable habitat, fair production and consumption respecting the limits of the environment. A new way of living, preventing over-consumption and over-exploitation of natural resources is urgently needed to ensure environmental resiliency and sustainable development of the planet. Under this theme, we will discuss how Social and Solidarity Economy can contribute to alleviating the impact of climate change.

SSE for Inclusiveness, Social Cohesion, Culture and Migration, Solidarity and Equity

To fight against inequalities and discrimination, solutions need to be developed by all stakeholders to effectively protect the rights and dignity of all. The Social and Solidarity Economy (SSE) has played an important role in providing an equal opportunity to all by mitigating growing inequalities and discrimination between individuals and territories, between urban and rural areas through its principle of putting humans before capital. Rooted in the local communities, SSE organizations and enterprises have greatly contributed to maintaining the social fabric within communities and territories, and building social cohesion in all countries, thereby responding effectively to the urgent needs of the people. Under this theme, we will discuss how to contribute better to social cohesion, ensuring equal opportunities for all, and linking productive activity of SSE to social needs based on values of solidarity, participation, inclusion and equity.

Democratic Governance

Social and Solidarity Economy (SSE) principles of autonomous management, participation and collective decision-making assure its capacity to achieve societal goals. Its democratic governance and collective ownership are essential for the transparent and effective use of resources. Under this theme we will discuss how to build partnerships and collaboration among public and private actors and communities to maximize socio-economic and environmental impacts. Because SSE is an exercise in participatory democracy, so as to benefit all, the process must be based upon democratic values and effective participation by all.


 **APPLY**

Selected initiatives will be presented during thematic workshops of the GSEF2020 main Forum and selected self-organized sessions will be part of both the Pre-forums and the main Forum. Individuals/organizations/institutions whose proposal was selected will be notified within 2 months after the submission deadline, after being reviewed by the GSEF2020 academic committee according to the following criteria for each thematic area. Due to very limited space and time allotted for self-organized sessions, the number of selected proposals will be limited to ONE per entity.

SELECTION CRITERIA

-  Gender balance, geographic diversity and important factors including the representation of youth, women and indigenous peoples will be considered at the time of selection.
-  Preference will be given to the GSEF members.
-  Projects and initiatives built on collaboration between governments and SSE organizations & enterprises for the co-creation of public policies will be given priority.
-  Submission of initiatives and projects built on innovative practices and approaches is encouraged.

Only individuals or institutions whose initiative was selected will be contacted within 2 months after the submission deadline.





3. PRE-FORUMS (OCT 19TH & 20TH)

As part of the GSEF2020, Pre-forums will be held on 5 themes: **Indigenous Peoples and Communities, Youth, Women & Gender, Local Governments & Public Policies, and Day for Researchers.**

Besides the 4 thematic pillars of the Forum, these transversal themes will bring opportunities to listen to all voices, reflect on relevant current issues and identify the best solutions responding to the challenges towards an inclusive and sustainable society through collective, collaborative and human-centered approaches. Pre-forums will also provide time and space for those groups to network, share and exchange experiences and ideas to work together.

Pre-forums and networking events will be organized under these themes in the form of workshops, exhibitions, debates, and meetings on 19th & 20th October.

IV. HOW TO APPLY

COMPLEMENTARY INFORMATION

We welcome initiatives and projects demonstrating the contribution of Social and Solidarity Economy to the inclusive and sustainable development of territories and the wellbeing of citizens. These projects may have been designed and implemented by Social and Solidarity Economy organizations, local governments, or through cooperation between different agents. GSEF2020 thematic workshops will generally group three to five initiatives under one common sub-theme.

- **Expected duration of the workshops:** one-and-a-half hours (time allocated for the total number of initiatives presented in each workshop session)
- **Deadline for submission:** **Tuesday March 31st, 2020**
- **Languages:** Initiatives/session proposals should be submitted in English, Spanish or French.
*Simultaneous interpretation in English, Spanish and French will be provided during the GSEF2020 main Forum. However please note that this service is not guaranteed for every thematic workshop session.
